

Ordinance 2010-1

AN ORDINANCE OF TOWNSHIP OF CONEWAGO, DAUPHIN COUNTY,
PENNSYLVANIA, AMENDING THE TOWNSHIP OF CONEWAGO CODE OF ORDINANCES
BY ESTABLISHING STOP SIGNS AT THE INTERSECTIONS OF THE DESIGNATED
ROAD/STREETS LYING WITHIN THE TOWNSHIP OF CONEWAGO.

SECTION 1. Chapter 15, Motor Vehicle and Traffic, Part 2 Traffic Regulations, §213, Stop Intersections Established is hereby revised, to add the following stop signs as follows:

SECTION 3. This revision is adopted pursuant to Pennsylvania Consolidated Statutes Annotated, 75 Pa. Vehicle Code §3323 and §6124 and based on an Engineering and Traffic Study completed pursuant to Pennsylvania Department of Transportation Publication 201.

SECTION 4. Declaration of Purpose. It is declared that the enactment of this article is necessary for the protection, benefit and preservation of the health, safety and welfare of the inhabitants of the Township.

SECTION 5. Repealer. All ordinances or resolutions or parts of ordinances or resolutions conflicting herewith are hereby repealed.

SECTION 6. Severability. The provisions of this Ordinance are severable and if any section, sentence, clause or provision hereof shall be held illegal, invalid, or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses or provisions of this Ordinance. It is hereby declared to be the intent of the Board of Supervisors of Conewago Township that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, sentence, clause or provision had not been included herein.

SECTION 7. Nothing in this ORDINANCE hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause of action acquired or existing, nor shall any just or legal right or remedy or any character be lost, impaired or affected by this ORDINANCE.

SECTION 8. This ORDINANCE shall become effective on the earliest date permitted by law after enactment.




