Dan King – States that PA Gaming Funds should be used for leaf equipment. States that the residents of their development have been helping the Township for many years, but they will no longer be doing so.

Dave Lehman – States that everyone does not use the park.

Maggie McCluskey – Concerned with the discontinuation of leaf pickup, and that money is going to the park.

Legro states that the Park improvements are primarily paid for by Grants that were obtained years ago.

Toby Breon – Concerned with the safety of the roads, and states that the year the leaf machine was broken the roads were very unsafe.

Dave Tobias – Asks where the current minutes and agendas are on the website, where can information be found. Hunt directs him to the location on the website.

Beth Hummer – States that the Township must evolve to account for the volume of leaves due to the age of the trees in their development, shares concern with public safety due to discontinuance of Leaf Pickup. States that residents will no longer be assisting Township with leaf pickup.

Heidi Tobias – States that the school buses and children are her concern. There are many leaves in the road. Urges the board to make a decision for the safety of the community. Long responds that the roads will be kept clear.
